School Annual Education Report (AER) Cover Letter

Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2012-2013 educational progress for Conner Creek Academy East Michigan Collegiate High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability and teacher quality. If you have any questions about the AER please contact the school office for assistance.

The AER is available for you to review electronically by visiting the following web site: www.connercreekeast.org, you may review a copy in the principal's office, or you may request a copy be mailed to you by contacting the school office.

The state has identified some schools with the status of Reward, Focus or Priority. A Reward school is one that is outperforming other schools in achievement, growth, or is performing better than other schools with a similar student population. A Focus school is one that has a large achievement gap in 30% of its student achievement scores. A Priority school is one whose achievement and growth is in the lowest 5% of all schools in the state. Michigan Collegiate High School has not been given one of these labels.

Some of the key challenges facing Michigan Collegiate High School are to continue to raise our students' test scores on the state assessment, ACT/MME. Over the past 4 years we have been using the Transformation Plan that the state required to help guide us in making these improvements. By the end of the 2013-2014 school year we should be completed with this process and making further growth in the area of Career and College Readiness.

State law requires that we also report additional information:

- 1. As a charter school Conner Creek Academy East/Michigan Collegiate admits students on a first come first serve basis.
- 2. We are making progress on our School Improvement Plan while making adjustments annually to better meet the needs of our students.
- 3. We have no specialized schools at Conner Creek Academy East/Michigan Collegiate.
- 4. Our curriculum is located on our website. All of our teachers use monthly pacing guides to deliver their instruction. We are aligned with the state model Common Core.
- 5. Michigan Collegiate High School only uses the ACT/MME which results are included with this report.
- 6. Michigan Collegiate High School averages about 50% attendance at Parent Teacher Conferences which represents approximately 225/450 students.
- 7. For Michigan Collegiate High School
 - A. We had 25 seniors out of 107 that qualified for dual enrolled at Macomb Community College.
 - B. We do not offer any AP/IB classes.
 - C. None.
 - D. None.

I would like to say thank you to all of our parents, students and staff for making Michigan Collegiate High School such a successful school. Even with the challenges facing the school in the future I am confident that as we all work together we will be making a difference in the lives of children.
